

Bounty Bucks (\$BBS) White Paper

1. Introduction

Bounty Bucks (\$BBS) is the official cryptocurrency of the FunFart Games Ecosystem. It serves as an in-game currency, a means of unlocking exclusive utilities, and a medium for decentralized staking and trading. By adopting Proof-of-Work (PoW) consensus, \$BBS ensures a robust, secure, and decentralized network. Our token emphasizes community-driven value creation and ecosystem sustainability.

2. Asset Classification

\$BBS as a Commodity

\$BBS qualifies as a **commodity** due to its decentralized nature, scarcity-driven value mechanisms (burn strategies), and functional roles within the ecosystem:

- **Tradability:** \$BBS can be freely traded on decentralized exchanges.
- **Utility-Driven:** Functions as a medium for accessing FunFart Games' features and benefits.
- **Scarcity:** Burn strategies ensure long-term supply reduction, resembling other commodities with finite resources.

Avoiding Securities Classification

To avoid being classified as a security:

1. **Utility Focus:** \$BBS's primary use lies in accessing in-game features and unlocking exclusive content, not speculative investment.
 2. **No Profit Expectations:** Value accrues through usage within the ecosystem, not external managerial efforts.
 3. **Decentralization:** PoW consensus ensures distributed control and operational transparency.

3. Proof-of-Work (PoW) Consensus

Why PoW?

1. **Security:** PoW provides a highly secure network, preventing fraud and double-spending.
2. **Decentralization:** Mining \$BBS ensures that no single entity controls the network.

3. **Incentives:** Miners contribute computational power to validate transactions and are rewarded with \$BBS.

Mining Rewards
